Product Structure

The Mini-Future Short allows investors to profit from the downward (bearish) trend of an Underlying. The Mini-Future Short moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency down and vice versa taking into account the conversion ratio and the adjustments of the Financing Level.

If the value of the Underlying at any time during the product life time lies at or above the Current Stop Loss Level, the Mini-Future Short expires immediately and is redeemed at market price. The Investor shall be aware that the occurrence of a Stop Loss Event will be determined in the sole discretion of the Calculation Agent.

The risk of loss is limited to the invested capital.

2. Prospects of Profits and Losses

Market Expectation Investors expect the Underlying to decrease in value over the life of the Product and accordingly expect to benefit from a leveraged performance relative to the Underlying. In any case Investors expect that no Stop-Loss Event will occur.
