This approach forms the basis for the investment manager's qualified market assessment, from which investment decisions are derived.

Issuer Risk

Specific modification rules for certain types of Underlyings stated in the base prospectus shall prevail. If the Issuer determines, for whatever reason, that an adequate modification is not possible, the Issuer has the right to redeem the products early.
