Unless a Barrier Event has occurred, this Product offers the Investor on the Redemption Date the maximum of the Denomination multiplied by the Bonus Level (in %) or the Denomination multiplied by the Final Basket Level divided by the Initial Basket Level. If a Barrier Event has occurred, the redemption of the Product will depend on the value of the Underlying Component, with the Worst Performance, as described in section "Redemption".
