Product Description

This Product offers the Investor a Coupon Rate regardless of the performance of the Underlying during the lifetime. If at the Final Fixing Date none of the Underlyings closes at or below the Strike Level, the Investor will receive on the Redemption Date a Cash Settlement which equals the Denomination. Otherwise the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption".

In addition, the Product can be early redeemed if the relevant conditions are met on any of the Autocall Observation Dates.
