If a Knock-in Event occurs and if the Final Fixing Value of at least one Underlying is below the Cap Level, the investor will receive a physical delivery of a number of Underlyings as defined in Ratio of the Underlying having the largest negative performance. This negative performance is reduced by the guaranteed Coupons paid out during the term.

Issuer Risk
