A Bonus Outperformance Certificate offers the Investor on the Redemption Date a leveraged participation in the Performance of the Underlying above the Bonus Level. If no Barrier Event has occurred, the Investor will at least receive on the Redemption Date the Bonus Level multiplied by the Denomination. If a Barrier Event has occurred, the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption".

Swiss Federal Income Tax (for private investors with tax domicile in Switzerland)	For tax purposes this Product is classified as transparent, where the majority of the return of the bond part is in the form of a discount or of one payment on the Redemption Date (IUP).
