However, the redemption of the Bonus Amount ceases to apply if a Barrier Event occurs. The determination of the redemption at maturity is dependent on the price performance and the final fixing price of the Underlyings: If no Barrier Event has occurred, at least an amount equal to the Bonus will be paid out. ## Prospects of Profit and Losses

A potential gain is the difference between the Issue Price and the price at redemption. These products have a minimum redemption defined by a Barrier and thus only conditional minimum redemption in the Bonus Amount: if a Barrier Event occurs, the conditional minimum redemption is immediately cancelled. The investor should note that this case may occur at the relevant Barrier Monitoring (period of time or point(s) of time). Accordingly, the risks of an investment in these products are substantial and largely correspond to the risks of a direct investment in the Underlying. In extreme cases (if the closing price of the Underlying is zero), the maximum loss can lead to a complete loss of the invested capital. Even if the performance of the Underlyings is positive and no Barrier Event has occurred, the price of the product during the term can be considerably below the Issue Price. ## Significant Risks for Investors

### Currency risks

### Market risks

### Disruption risks

### Secondary market risks

Under normal market conditions, the Issuer or the Lead Manager intend to post bid- and ask-prices on a regular basis. However, neither the Issuer nor the Lead Manager is under any obligation with respect to investors to provide such bid- and ask-prices for specific order or securities volumes, and there is no guarantee of a specific liquidity or of a specific spread (i.e. the difference between bid- and ask-prices), for which reason investors cannot rely on being able to purchase or sell the products on a specific date or at a specific price.
