Product Description

This Product offers the Investor a periodic opportunity to receive a Conditional Coupon Amount. If all Underlyings close above the Strike Level on the Final Fixing Date, the Investor will receive the Denomination on the Redemption Date. In addition, the Target Mechanism allows the Investor to benefit from receiving back the Denomination if the Target Event has occurred. Otherwise the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption". In addition, the Product can be early redeemed if the relevant conditions are met on any of the Autocall Observation Dates.
