This Product offers the Investor a Coupon Rate regardless of the performance of the Underlyings combined with conditional downside protection. If the Barrier Event has not occurred, the Investor will receive on the Redemption Date a Cash Settlement in the Settlement Currency equal to the Denomination. If a Barrier Event has occurred, the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption".

The Issuer has the right for Early Redemption, as further described in "Early Redemption" below.
