Swiss Federal Income Tax (for private investors with tax domicile in Switzerland) For tax purposes this Product is classified as non-IUP (non-interest unique predominant). Therefore, for private Investors with tax domicile in Switzerland holding the Product as part of their private property, the Coupon Amounts on the relevant Coupon Payment Dates is subject to the Federal Direct Tax. However, any gain derived from the option is considered as capital gain and is therefore not subject to the Federal Direct Tax for such taxpayers.
