## Profit and Loss Expectations at Maturity

### 2. Profit and Loss Expectations at Maturity

A ZKB Put Warrant offers the opportunity to disproportionately benefit from a negative performance of the Underlying due to the leverage effect. The profit prospects for the ZKB Put Warrant are limited and are reached when the price of the underlying falls to zero. A potential profit consists of the positive difference between the achieved selling price or redemption amount and the Issue or purchase Price. The amount of the redemption payment depends – taking the ratio into account – on the extent to which the closing price exceeds the Exercise Price on the Exercise Date and may be influenced by exchange rate variations. The ZKB Put Warrant has a fixed term. The loss potential is limited to the invested capital, which corresponds to a total loss. The risk of this investment is significantly greater than that of a direct investment due to the leverage effect.

### 3. Material Risks for Investors

<b>Issuer Risk</b>	Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the product not only depends on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this product.
<b>Specific product risks</b>	Put Warrants involve the risk of losing the entire initial capital (purchase price).
