Issuer

1. Product specific conditions and product description

The investor benefits both from a falling Underlying and from the rising volatility of the Underlying. The investor has the right (not the obligation) to demand a cash settlement amount equal to the difference between the price of the Underlying on the Expiry Date (European) and the Exercise Price (taking into account the Ratio). Warrants are suitable for investors with a high risk tolerance who invest the Issue Price in order to speculate on the future performance of the Underlying or to hedge a portfolio against market fluctuations. A ZKB Put Warrant offers the opportunity to disproportionately benefit from a negative performance of the Underlying due to the leverage effect. The profit prospects for the ZKB Put Warrant are limited and are reached when the price of the underlying falls to zero. A potential profit consists of the positive difference between the achieved selling price or redemption amount and the Issue or purchase Price. The amount of the redemption payment depends – taking the ratio into account – on the extent to which the closing price exceeds the Exercise Price on the Exercise Date and may be influenced by exchange rate variations. The ZKB Put Warrant has a fixed term. The loss potential is limited to the invested capital, which corresponds to a total loss. The risk of this investment is significantly greater than that of a direct investment due to the leverage effect.
