In addition, the Investor has the opportunity to participate in the performance of the Underlying Basket above the Bonus Level (in %) up to the Cap Level (in %). If a Barrier Event has occurred, the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption".

## REDEMPTION

<b>Swiss Federal Income Tax (for private investors with tax domicile in Switzerland)</b>	For tax purposes this Product is classified as transparent, where the majority of the return of the bond part is in the form of a discount or of one payment on the Redemption Date (IUP).
