The investor has the right (not the obligation) to demand a cash settlement amount equal to the difference between the price of the Underlying on the Expiry Date (european) and the Exercise Price (taking into account the Ratio). The product is therefore suitable for investors with a high risk tolerance who are willing to invest the Issue or purchase Price to speculate on the future performance of the Underlying or to hedge certain positions against market fluctuations. The potential return from the investment amount is overproportionately higher than direct investment in the Underlying due to the Leverage effect.
