Swiss quality companies: Priority is given to financially robust companies with a strong market position, a clear strategic direction and solid earning power.2. High-growth mid and small caps: Medium-sized to smaller companies with attractive growth potential complement the basket and increase the chances of achieving above-average value appreciation.3. Stable Blue chips as a foundation: Leading SMI heavyweights ensure stability in the portfolio and serve as a defensive anchor during volatile market phases. <p>Further information on the Investment Strategy, investment directives, and investment restrictions are available free of charge from the Investment Manager.</p>

Roles and responsibilities The Investment Manager decides on the composition of the Reference Portfolio, the weighting of the component securities, and the size of the cash component, in accordance with the investment universe and management rules (see below). The Investment Manager alone is responsible for monitoring and complying with the management rules described below.

The product's performance therefore depends on the Investment Manager's investment decisions. The Investment Manager takes full responsibility for the composition of the Reference Portfolio and its impact on the Certificate's performance.

The Issuer will, on a best-effort basis, execute the buy and sell orders necessary to issue or rebalance the Certificate. The Issuer disclaims all liability with regard to compliance with the management rules and the Certificate's performance.

INVESTMENT UNIVERSE AND MANAGEMENT RULES

Cash component The cash component forms an integral part of the Certificate's Reference Portfolio but does not count towards the minimum number of component securities.

Cash components do not earn interest but could generate negative interest.

The cash component is denominated in the base currency of the Reference Portfolio.

Equities The shares must be listed on the SIX Swiss Exchange or a stock exchange outside Switzerland with regulations equivalent to those of the SIX Swiss Exchange.

The companies must have a market capitalization of at least CHF 100m (or the equivalent in another currency).

At each rebalancing, the weighting of any new security may not exceed half of its average daily trading volume over the previous five days.

Additional information If the rules governing the investment universe are violated (following a corporate action, for example), the Investment Manager will adjust the allocation during the following rebalancing in order to restore compliance.

Management rules for the Reference Portfolio

1. The Reference Portfolio is denominated in CHF.
2. The basket will contain at least 5 securities but no more than 30, and it will have a cash component denominated in the Reference Portfolio's base currency.
3. The Investment Manager may rebalance the Reference Portfolio up to 20 times per year. In exceptional cases, rebalancings will be authorized without being counted. Exceptional cases are defined as significant dividend reductions and corporate actions such as tender offers, mergers, and spin-offs.
4. Securities included in the basket must be denominated in CHF
5. The annual average sum of the cash components (and cash equivalents) may not exceed 50%.
6. Secondary-market trading of the Certificate will be suspended during rebalancing periods. Only one rebalancing can take place at a time.
7. Any deviation from the Reference Portfolio's management rules will lead to an adjustment of the allocation at the next rebalancing.
8. No leveraged positions (i.e., where the Certificate's gains or losses on a component security are not exactly equal to the security's performance) or short positions (i.e., short selling) are allowed in the Reference Portfolio.

Investment restrictions It may take the Issuer several business days to implement the Investment Manager's investment decisions, depending on market liquidity or if a transaction cannot be executed for technical reasons. Based on these factors only, no guarantee can be made that investment decisions will be implemented on the same day that instructions are received.

The Issuer reserves the right to refuse to execute a buy order if the component security in question is subject to an investment restriction for technical reasons or any other reason.

Securities with an investment restriction include those issued by companies that represent a reputational risk for the Issuer or that are not in keeping with the Issuer's code of conduct (for instance, the Issuer currently does not invest in companies involved in cluster munitions).

If a component security is not in compliance with the Issuer's investment restrictions, it will be replaced at the next rebalancing of the Reference Portfolio. If the next rebalancing does not take place within a reasonable period of time, the Issuer reserves the right to sell the component security at its discretion.
