### Product Description

The Long Mini-Future allows the Investor to profit from the upward movements of the Underlying. The Current Financing Level and Current Stop-Loss Level are adjusted daily. If a Stop-Loss Event, as defined below, has occurred, the Product expires immediately and is redeemed in accordance with the section "Redemption". The Mini-Future does not have a fixed maturity (open end), but they may be exercised by the Investor or terminated by the Issuer.
