## 1. Product specific conditions and product description

ZKB Put Warrants with Knock-Out Open-End allow for a disproportionately high participation in the negative performance of the Underlying, corresponding to the Leverage. Accordingly, the product can be used for speculation or hedging purposes. It is therefore suitable for investors with a high risk tolerance who are willing to invest the Issue or purchase Price to speculate on the future performance of the Underlying or to hedge certain positions against market fluctuations.

These products do not have a fixed term (Open-end) but can be exercised from the First Exercise Date (American style). Additionally, they have a Knock-Out Level, upon which reaching or exceeding during the Knock-Out Level Observation Period, they immediately expire worthless. The Current Knock-Out Level always corresponds to the Current Exercise Price and is adjusted on each trading day. In this case (or in the event of termination by the issuer), the investor receives the repayment amount defined below.

Interest is charged daily on the capital provided by the issuer, consisting of a money market interest rate and a financing spread.

### **2. Profit and Loss Expectations at Maturity**

#### **Profit and Loss Expectations at Maturity**

The product offers the opportunity to disproportionately benefit from a negative performance of the Underlying due to the leverage effect. The profit prospects for the product are limited and are reached when the price of the underlying falls to zero. A potential profit consists of the positive difference between the achieved selling price or redemption amount and the Issue or purchase Price. The amount of the redemption payment depends – taking the ratio into account – on the extent to which the closing price exceeds the Current Exercise Price on the Exercise Date and may be influenced by exchange rate variations.

The product does not have a fixed term, but expires immediately worthless if the Current Knock-Out Level is touched or breached. The loss potential is limited to the invested capital, which corresponds to a total loss. The risk of this investment is significantly greater than that

of a direct investment not only due to the Leverage effect but also because of the risk of a Knock-Out Event occurring.
